



# Green Stormwater Infrastructure Mini-Grants | Program Introduction

#### **Green StormwaterInfrastructure Mini-Grants Program (GSI Mini-Grants)**

Tucson Clean & Beautiful (TCB) by formal agreement with the City of Tucson Water Department invites neighborhood associations, community groups, non-profit organizations within the Tucson City limits to submit proposals for the Green Stormwater Infrastructure (GSI) Mini-Grants program.

#### Tucson Clean & Beautiful (TCB)

TCB is a 501(c)(3) non-profit contracted by the City of Tucson Water Department to provide administrative oversight of funds, coordinate and manage the process, selection and implementation of applications for GSI Mini-Grants projects.

#### **Funding Available**

The GSI Mini-Grants Program is funded through the Water Conservation Fund which was established by the Mayor & Council through adoption of ordinance 10555 on May 20, 2008. Approximately \$50,000 is available for projects annually within each of the City Wards.

#### **GSI Benefits**

Green Stormwater Infrastructure projects are an efficient and effective way to provide environmental, social, and economic benefits to the Tucson community. GSI projects that incorporate passive stormwater harvesting, trees and other native vegetation provide many benefits including the following:













#### Project Evaluation/Selection

Projects will be selected based on the following criteria with a **total possible point value of 30** (*Project feasibility is also taken into account as there can be conflicts with utilities, excessive flooding, historic/cultural preservation designations etc. that impact project feasibility and prevent GSI implementation):* 

#### 1) human health: (1-10 points)

Average (pre-existing) tree canopy of proposed GSI project sites, number of trees and plants proposed, average Heat Vulnerability Index and Neighborhood Vulnerability Index scores, increased access to quality outdoor space

### 2) environmental health: (1-10 points)

stormwater management (water harvesting, erosion control, flood mitigation), restore and increase urban environmental habitat, water conservation, square footage of newly proposed GSI project sites

#### 3) community welfare: (1-10 points)

neighborhood beautification, traffic calming for safety of pedestrians and bicyclists, neighborhood pride, neighborhood participation, number of citizen-initiated applications/inquiries from Ward Offices, expected citizen participation in monitoring activities

#### Ways to Apply

There are multiple ways to apply for the GSI Mini Grants program. For applicants in Wards that are highly competitive in submitting grant applications, it is recommended that you utilize one of the three full application formats. Grant applicants must contact TCB GSIMG program staff prior to submitting your application.



• Online application form (full format)



• Written application - print and fill, mail in/drop off (full format)



• Attend virtual presentations and apply with GSIMG program staff (full format)



• Phone application / photo submission (short format)

#### Need Help Getting Started? (follow these steps)

Contact GSI MG program staff by email or phone to discuss your project or interest in the program.
Attend a virtual GSI MG information presentation, or request a presentation for your neighborhood group.
Send photos and/or a project description to a GSI Program Manager by text or email.
Find at least 3 other people in your neighborhood to participate in the design/planning/application/neighborhood outreach process
Determine the most appropriate application method for your project proposal
Compile the required Application Documents and sign the Project Agreement Form, contact program staff for any assistance needed.
Submit the application by email, mail, phone or deliver hardcopy to TCB office.

#### **Project Proposal Required Documents**

- 1) Complete Green Stormwater Infrastructure Mini Grant Application
- 2) Letter of support from governing jurisdiction (HOA, Parks and Rec, School, Neighborhood Association)
- 3) Complete TCB Adopt-a-Place project application for project area
- 4) Letter of support from City Council Ward Office (should project be accepted by Tucson Clean & Beautiful)

#### **Proposal Deadlines**

Application review cycles occur 3 times a year.

March 1st July 1st November 1st

Applications must be completed and submitted to GSIMG@tucsoncleanandbeautiful.org, in person or via mail. Contact by email prior to dropping off application in person.

3. Explain the value of the project to your neighborhood.

4. What problems / issues might the project solve if it were to be built? (i.e. traffic calming, pedestrian safety, erosion, flooding, activate public space, shade in an urban heat island).

## **Project Maintenance**

- 1. It is required that there be buy-in from multiple residents. List at least 3 other community members / neighbors that support this project being built. (They should be residents that live adjacent to the project site).
- 2. Watering and follow-up monitoring will be required for two (2) years. List at least 3 people that have committed to assist in the watering and/or monitoring of the project.
